It was another "First" for EFO, a hybrid Annual Meeting. The Activities Committee, led by Paula Hofford, did a fantastic job of lining up speakers that had topics relevant to what is impacting EFO member companies today as well as setting up a beautiful day of golf overlooking downtown Tulsa from the Osage hills.

The theme this year was "Environmental Federation of Oklahoma: 30 Years of Purpose, People, Passion & Programs". It was very appropriate considering that EFO has been an Oklahoma institution ensuring that "Oklahoma provides an environment conducive to a high quality of life for all Oklahoman's through balanced, responsible economic growth and protection of our natural resources". Our mission is as relevant today as it was in 1991.

Even with the pandemic, we had over 220 environmental managers, regulators, consultants, and students registered to attend this year's event. The Acting Region 6 Administrator, David Gray opened the conference with a Keynote speech followed by Ken Wagner, Oklahoma Secretary of Energy & Environment. Ken spoke to the group about the state of energy and environmental issues in Oklahoma as well as insights to what to expect from EPA. Then Scott Thompson gave us an update on the state ODEQ. After the Frank Condon Awards Lunch, we heard about the Triple Bottom Line Scor3Card, Cybersecurity, and the Drive Act and its impacts on the OCC. We had great panels on Water Quality Resources where PFAS was discussed among other issues, and Land Protection where PFAS was also discussed among other issues.

On Thursday, we had keynote talks on McGirt and an update on the Oklahoma Medical Marijuana Authority. (I never thought we would be discussing marijuana at an EFO conference!) We had fantastic panels on health and safety, wildlife, and air quality issues, and ended the conference with the annual membership meeting where we voted on a new chairman - Dr. Darrell Townsend from GRDA, a new vice -chairman - Mr. Jeff Everitt form OGE, and retained Mr. Gerald Butcher as Treasurer and Steve Landers as Secretary.

Even the Hospitality Suite was one to be remembered! There was great music, great food, and the Photo Booth was a great hit with many!
